The Yellow Book outlines all requirements for governmental audit reports, professional qualifications for auditors, and audit organization quality control.

This course will describe when the Yellow Book standards must be applied, and it will identify the new organization and format of the 2018 edition of the Yellow Book. Finally, the course will cover the five areas that changed in the 2018 Yellow Book from the 2011 Yellow Book.
